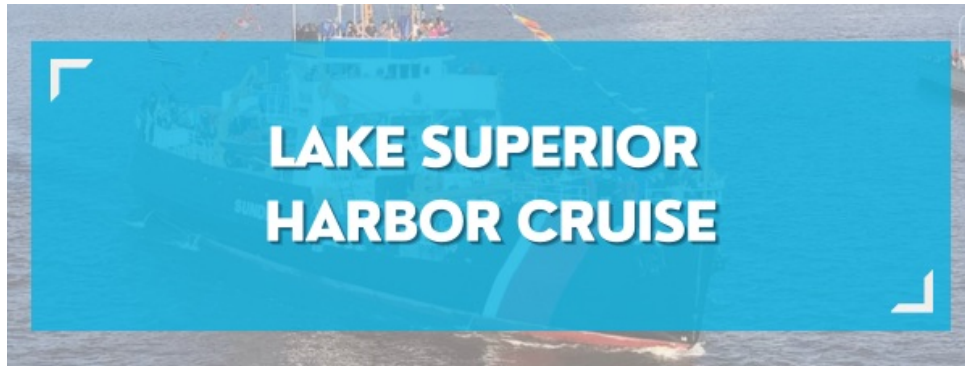

ECONOMIC ROUNDUP: JUNE 2025

ECONOMIC ROUNDUP: Some Signs of Waning Momentum

Construction-specific economic data have started to flash a few signs of potential weakness.

Both backlog and nonresidential construction spending declined for the month, and while nonresidential employment continues to grow at a healthy pace, the residential segment is now contracting. While materials prices are still up just 1.3% over the past year, prices have risen too quickly over the first five months of 2025, especially those subject to elevated tariffs.

Nonresidential Construction Spending Slips in April

Nonresidential construction spending fell in April, with a particularly large decrease in private sector activity. Private nonresidential spending has now fallen in three of the first four months of 2025 and is on pace to decline 4% over the course of the year. While data center investment continues to rise, fewer other subsegments are currently exhibiting momentum.

Input Price Escalation Continues

Construction input prices continued to rise in May and have now increased at roughly a 6% annualized rate through the first five months of 2025. Emerging escalation is largely due to rapid price increases for tariff-affected goods like iron and steel, and this data predates the recent increase in iron and steel tariffs from 25% to 50%.

Nonresidential Contractors Continue to Hire

Nonresidential construction employment grew by 11,300 positions in May and has now increased at over twice the rate of the broader economy over the past year. The residential segment fared less well, losing more than 7,000 jobs in May as high interest rates weigh heavily on homebuilding activity.

Backlog Falls, Contractors Remain Confident

ABC's Construction Backlog Indicator fell sharply from April's 20-month high. Despite the decline, backlog remains 0.1-months above year-ago levels. Contractors remain broadly confident about the next six months, with sales, profit margin and staffing expectations all up on a year-over-year basis.

Looking Ahead

Despite emerging signs of weakness, contractors remain confident about the remainder of 2025. Softer-than-expected inflation data for May suggest that there could be more rate cuts than previously anticipated this year. If that occurs, lower borrowing costs will provide a welcome tailwind for the construction industry.

DEED AWARDS \$5M+ TO GREATER MINNESOTA

DEED Awards Infrastructure Grants to Three Cities

The Minnesota Department of Employment and Economic Development (DEED) has awarded more than \$5-million in grants to three infrastructure projects in Greater Minnesota.

The funding, from DEED's Greater Minnesota Business Development Public Infrastructure Grant Program (BDPI), is expected to create or retain 1,006 jobs in North Branch, Sartell, and Willmar and leverage \$221-million in private investment.

North Branch - \$1,050,860

DEED awarded the city of North Branch \$1,050,860 to support street and utility construction in the city's 200-acre, multi-phased Interstate Business Park.

The project will immediately provide infrastructure for two businesses: LEI Packaging, which currently has 15 full-time jobs in Chisago City and is building a new, larger \$5-million facility in North Branch, with plans to add 25-50 more workers in the next five years; and Stepp Manufacturing, currently headquartered in a different North Branch location with 71 full-time employees, with plans to invest \$9.5-million in a new facility and add 25-50 employees in the next five years.

The Interstate Business Park projects will also prepare an additional 30-acres for future development. Officials estimate the project will attract \$30-million in private investment and create or retain 186 jobs in five years.

Sartell - \$2,000,000

DEED awarded the city of Sartell \$2-million to support street and utility construction for Niron Magnetics, which intends to break ground this year on a \$38-million, 190,000-square-foot building and create 175 full-time manufacturing jobs. The company anticipates investing an additional \$62-million in future expansion on the site, creating an additional 425 full-time jobs. The total cost of the public infrastructure project is \$4,394,000.

Willmar - \$2,000,000

DEED awarded the city of Willmar \$2-million to assist with street and utilities construction to expand the city's industrial park and provide access to a new private retail park. The proposed public infrastructure will benefit current businesses and create 250-acres for future development. Officials estimate the project will attract \$91-million in private investments and create or retain 220 jobs in five years. The total cost of the public infrastructure project is \$4,492,660.

Under the [BDPI grant program](#), which supports communities outside of the Twin Cities metropolitan area, DEED awards 50% of eligible capital costs for qualifying public infrastructure projects such as streets, wastewater collection and treatment, drinking water, storm sewers, and more.

☐ [How Supply Chain Transparency Can Help Businesses Offset Tariff Costs](#)

Construction businesses across the U.S. are bracing for the impact of new and anticipated tariffs on imports from China, Mexico, Canada, and other countries. And with costs of raw materials and equipment likely to rise, decision-makers in the sector realize their supply chains may be less resilient than anticipated. From material sourcing to compliance obligations, the downstream impact of tariffs is forcing the industry to rethink long-held assumptions about supplier relationships and operational risk. *(For Construction Pros)*

☐ [Canada Threatens Further Tariffs on US Steel, Aluminum](#)

Canada may soon raise tariffs on U.S. steel and aluminum imports if the two countries are unable to reach an agreement pertaining to the Trump administration's trade policies in the next month. The new tariffs from Canada are slated to begin July 21, a little less than two weeks after a 90-day pause on country-specific reciprocal tariffs from the U.S. is set to expire. Canada would impose the tariffs "to level consistent with progress that has been made in the broader trading arrangement with the United States," per a June 19 press release. *(Supply Chain Dive)*

GREATER MINNESOTA | WATER INFRASTRUCTURE

☐ [Greater Minnesota Water Projects Will Flow From Bonding Package](#)

Three-hundred miles separate Appleton from Aurora, but big water infrastructure needs contrasted against limited tax bases put them in the same boat among Greater Minnesota communities. Appleton, in the western part of the state, has about 1,400 people. Far to the northeast, Aurora's population is slightly higher at 1,700. When cities are working with those numbers, building a new treatment plant for drinking or wastewater becomes a pipe dream without outside assistance. Minnesota's Water Infrastructure Fund (WIF) is a critical source of help for the two cities, plus dozens of others on the state's project priority list. The program's funding will keep flowing, mostly to Greater Minnesota, after legislators allocated \$87-million during a special session completed earlier this month. *(MinnPost)*

JOBSITE SAFETY

* [OSHA Hearings Hint at Revised Heat Rule](#)

When President Trump returned to the White House earlier this year, it appeared that OSHA's proposed heat rule would be abandoned. Comments during the agency's informal public hearings, which began June 16 and run through July 2, however, could indicate otherwise. Although the rule proposed at the end of President Biden's term may not come to pass, it's likely that some other form of a heat standard will enter OSHA rule books, experts say. (*Construction Dive*)

GREEN TECHNOLOGY | CONCRETE

□ [A New Kind of Concrete Can Grow & Repair Itself. How? It's Alive.](#)

Scientists are working to develop a concrete that "self-heals" to help mitigate concrete's climate impact, and in a new study, they have used a synthetic lichen to patch cracks autonomously, meaning that outside nutrients don't need to be applied for the repair to take place. The lichen --- actually a combination of cyanobacteria and fungi --- can draw food from sunlight and the atmosphere while also using calcium ions to produce calcium carbonate, which is the same ultra-strong material found in seashells and millennia-old Roman concrete. (*Popular Mechanics*)

Maplewood Affordable Housing Project Advances

Momentum is building for a long-anticipated project that will bring 40 new affordable housing units to Maplewood, including much-needed homes for families coming out of homelessness.

Beacon Interfaith Housing Collaborative says it has a "realistic path to closing" in late 2025 or early 2026 on the \$23-million Gladstone Crossing project, which includes 20-units for people who have experienced homelessness, have a disability, and are at 30% or less of the area's median income.

The remaining 20 units will be "workforce housing," with three dwellings at 30% AMI and 17 at 50% AMI, according to Beacon, a developer and operator of deeply affordable and supportive housing in the Twin Cities.

Located at 1375 Frost Avenue, the project site is served by excellent transit and is within walking distance of large parks, schools, the Gladstone Community Center, the Philippine Center of Minnesota and the Bruce Vento trail, the developer said.

Designed by Pope Design Group, the project will feature 30 two-bedroom, six three-bedroom, and four four-bedroom units, along with supportive services, bike storage, a fitness center, a playground, outdoor patio, gardening space, and underground parking.

Beacon is "not banking" on interest rates going down and has brought in a new general contractor who is "bigger and can secure more competitive pricing from subcontractors."
