**ECONOMIC REPORT: Struggling Industry Now Flying Blind**

*Due to the ongoing government shutdown, economic data for the construction industry is slim to none. Here is what Construction Executive could extrapolate.*

Recent data indicate that the construction industry is struggling, with both employment and spending shrinking over the past several months.

Unfortunately, "recent" is a relative term; the government shutdown has halted many data releases that would have occurred in October, and many of the freshest statistics now pertain to July or August.

**Uncertainty Clouds Outlook**

Economic uncertainty has reigned over 2025. The volatility of trade policy and the uncertain effects of tariffs on input prices have made it difficult to anticipate project costs, while immigration policy has reignited labor shortages even as industry-wide demand for labor softens. The government shutdown, now nearing a full month in length, only exacerbates that uncertainty.

**Construction Backlog Stable, Contractors Remain Confident**

Despite uncertainty and concerning economic data, ABC's Construction Backlog Indicator was unchanged at 8.5-months in September. While contractor confidence has declined slightly over the past few months, expectations for sales, profit margin and

hiring all remain positive and above year-ago levels.

### Materials Prices Begin to Rise

While the effects of tariffs on imported materials prices are obvious, higher import taxes also put upward pressure on domestically produced inputs. This is apparent in the most recent producer price index data, which indicates sharp increases in domestic prices for many key inputs, including copper and steel products.



### Spending and Employment: Causes for Concern

The most recent construction spending data, which pertains to July, showed ongoing declines in nonresidential activity. With the exception of data centers, virtually no private subsegments have exhibited growth over the past year. As a result, industry-wide employment declined in each of the last three months for which data is available.

### Looking Ahead

The lack of data releases in October has made it difficult to assess the industry's health. The one certainty, however, is that the extraordinary level of uncertainty that has defined the past several months remains firmly in place.

# SITE REDEVELOPMENT & DEMOLITION PROJECTS

## DEED Awards \$2.3M for Site Redevelopment & Demolition

On October 22nd, the Minnesota Department of Employment and Economic Development (DEED) announced nearly \$2.3-million for five site redevelopment and demolition projects statewide.

The four grants from DEED's Redevelopment Grant Program and one loan from the Demolition Loan Program are expected to redevelop 33.8-acres and establish 488 housing units.

### **Rogers - Willis Trucking**

DEED awarded the city of Rogers \$156,625 for abatement, demolition, and public infrastructure improvements on the 4.6-acre site located at 21601 John Deere Lane.

Formerly agricultural land, the site was developed for semi-truck maintenance and storage. The site will be redeveloped into a three-story, 181-unit, market-rate apartment building with underground parking.

### **Roseville Economic Development Authority (EDA) - Twin Lakes Technology**

DEED awarded the Roseville EDA \$373,000 for site demolition and public infrastructure improvements on this 12.5-acre site located at 1945 Twin Lakes Parkway.

Formerly used as a nursery and most recently as a trucking terminal and maintenance shop, the site will be redeveloped into a 152,250-square-foot light industrial tech building.

### **St. Paul - Grand / Victoria Redevelopment**

DEED awarded the city of St. Paul \$350,000 for abatement, demolition, and public infrastructure improvements on this 0.8-acre site at 841 - 857 Grand Avenue.

Formerly an automobile dealership and most recently a mall, the site will be redeveloped into a six-story, mixed-use building with 12,800-square-feet of commercial space and 90 residential units.

### **Wright County - Old Government Center Site**

DEED awarded Wright County \$867,500 for asbestos abatement and demolition on this 6.8-acre site in downtown Buffalo.

Formerly a gas station, a courthouse, and a jail, this site will be redeveloped into 16 single-family patio homes; two market-rate apartment buildings with a total of 201 units; 18,000-square-feet of commercial space; and a public marina.

### **St. Paul Port Authority (Port) - 245 Maryland Avenue East**

DEED awarded the Port \$173,900 for building demolition on this 9-acre site located at 235 and 245 Maryland Avenue East.

This site was first developed for big-box retail and formerly occupied by Kmart, and has the potential for a multi-story medical office development. The Port plans to issue a general obligation bond to secure the loan.

The projects will collectively retain or create 269 jobs, increase local tax bases by \$2.4-million, and leverage over \$157.9-million in private investment.

## CONSTRUCTION HEADLINES

Five construction-related headlines you need to read over the next coffee break.

### ARCHITECTURE BILLINGS INDEX (ABI)

#### □ [Architecture Billings Hit Lowest Point Since April](#)

Business conditions at architecture firms weakened further in September, with the AIA / Deltek Architecture Billings Index dropping to 43.3, the lowest since April. New project inquiries remained flat while design contract values declined for the 19th consecutive month. In September, billings declined across all U.S. regions except the Midwest, where they remained flat. By specialization, institutional firms reported the weakest conditions, while commercial / industrial firms saw continued softening after nearing growth over the summer. *(Inside Lighting)*

### GOVERNMENT SHUTDOWN

#### □ [Shutdown Delays Could Cost Construction Millions in Lost Work Hours](#)

Hays America, a recruitment firm specializing in professional staffing, has released new



analysis showing that U.S. government shutdowns can lead to millions of dollars in staffing losses across the construction and property sectors. Shutdowns have clear operational impacts on the trades. Permitting delays, paused federal contracts, and halted onboarding systems like E-Verify all slow construction activity and hiring. These disruptions hit both general contractors and subcontractors who rely on a consistent flow. *(Contractor Magazine)*

### CONSTRUCTION CONTRACTS | SCOPES OF WORK

#### □ [Slippery Scope: Understanding Your Scope of Work](#)

Would it surprise you to learn that one of the most important sections in your construction contract is the one your lawyer will probably spend the least amount of time on? In your lawyer's defense, lawyers aren't always privy to the nitty-gritty details of a project's scope of work --- details which are often added to a construction contract at the end of negotiations once the substantive legal terms have been blessed. Having a well-defined scope of work that clearly identifies, at the outset of the project, the work to be completed, the materials to be used, what's included in the cost, and, importantly, what's excluded from the cost, can save all parties involved from headache and heartache down the line. *(J D Supra | Hahn Loeser & Parks LLP)*

### MASS TIMBER | SUSTAINABLE BUILDING

#### □ [Mass Timber Demand is Growing. Ironworkers Say They're Ready.](#)

Mass timber is having a moment. In September, the number of multi-family, commercial, or institutional mass timber projects that were in progress or built had increased by more than fivefold from seven years ago, according to WoodWorks, a nonprofit that supports contractors on mass timber builds. With that demand comes a question: Amid an ongoing skilled labor crunch, who can contractors tap to build these projects? Ironworkers think they have the answer. *(Construction Dive)*

### 3D PRINTING | CONCRETE | ROBOTICS

#### □ [This 3D-Printed, Carbon-Absorbing Bridge is Inspired By Bones](#)

A research team at the University of Pennsylvania has combined novel concrete materials with a material-saving design, without compromising on strength and durability. The project, called Diamanti, takes inspiration from nature and uses a robotic 3D printer to create complex, lattice-like patterns with a sustainable concrete mixture. While most regular concrete absorbs carbon dioxide, Diamanti's enhanced concrete mixture absorbs 142% more carbon dioxide than conventional concrete mixes. *(CNN - Science)*

## Woodbury Approves Champions Hall Athletics Facility

A nearly quarter-million-square-foot multiple-use sports facility was given the green light by the Woodbury City Council last week.

The facility will be built out in vacant space in an industrial property built in 2022 and will serve as space for volleyball, basketball, lacrosse, and soccer, according to Woodbury planning documents.

The project, dubbed Champions Hall, was pitched by ARCO Murray and received approval last week from the City Council, two days after the Planning Commission recommended approval.

Champions Hall will take up only half of the space of the vacant building. As proposed, the facility would use 238,000-square-feet of the roughly 477,000-square-foot building. It is located at 11435 Hudson Road in Woodbury.

According to a presentation received by the planning commission, soccer is among the most popular high school sports, and it is among the top three sports for children ages 6 to 12 in the state.
